ACT+RGV Offers 2 Paths to Certification: INTERNSHIP or CLINICAL TEACHING

ADMISSION REQUIREMENTS

- Meet with ACTRGV representative for Interview and transcript review.
- An official transcript showing a 4-year degree from an accredited institution with the degree conferred date.
- Must have a minimum cumulative grade point average (gpa) of 2.5 or better on a 4-point system, or 2.5 gpa on the last 60 hours.
- Must meet 12/15 hours/specific courses in the area in which they wish to teach OR pass a TX PACT exam
 prior to admission into the program.
- Take and pass a Critical Thinking Exam with a minimum score of 45.
- TOEFL-IBT (Test of English as a Foreign Language Internet Based Test code B241) minimum Speaking score of 24, Listening score of 22, Reading score of 22, and Writing score of 21
- Submit the signed receipt for the Candidate Policy Handbook, the FERPA agreement, and admission letter
- Once the application and application fee are submitted, applicants will receive an "Approved Applicant Letter".

EDUCATOR PREPARATION CURRICULUM REQUIRMENTS:

COMPLETE INSTITUTE TRAINING - 150 hours must be completed prior to teaching

- Training schedule will be provided
- A down payment must be received at least one week prior to the start of the session. (See fees below)

CONTENT TEXES EXAM

Pass the TEXES content and content-related exam(s) at the earliest opportunity

FIELD-EXPERIENCE HOURS - Must be completed prior to teaching

- Complete 30 clock-hours of field-experience (observations in an accredited K-12 Texas school)
- Of the 30 hours, 15 must be interactive with students under a certified teacher's supervision
- Observations will be recorded on the actory observation form and submitted to the actory office
- School districts will require a TB test and a background check prior to entry into a classroom

INTERNSHIP REQUIREMENTS

BEGIN A ONE-YEAR INTERNSHIP AS A CERTIFIED TEACHER-OF-RECORD \underline{OR} BEGIN A CLINICAL TEACHING PLACEMENT

Note: To be recommended for a state-issued Probationary/Intern Certificate, candidates

- 1. Must submit an official transcript, in a sealed envelope, with a "degree conferred" notation.
- 2. Must submit proof of 30 Field-Experience Hours,
- 3. Must have completed all Institute (Training) 150 hours,
- 4. Must have passed the TEXES content exam related to the teaching assignment AND edTPA/or PPR 160,

One-year Intern Certificate available if only content/content-related exam(s) is/are passed

PREPARE TO TAKE edTPA/PPR 160 OR 370

- edTPA performance assessment (three tasks representing a cycle of effective teaching training sessions.)
- Make an appointment and take the representative form of the PPR 160 or 370(practice test)
- Attend scheduled edTPA Sessions (refer to calendar) or a scheduled six-hour PPR review

BEGIN CONTINUING PROFESSIONAL EDUCATION (CPE) HOURS

The Texas Education Agency requires candidates to complete 300 hours of continuing professional education (CPE) during their internship. Information about opportunities to meet this requirement will be posted on the website (www.actrgv.com).
